  - a. Funding request NOT from the house account
    - i. James Martins - I would like 1000 dollars, from the HLBAPS (House Level Board Approved Projects) account, for Sound dampening for the server room. or at least:

1. Cloyne Court house-wide quiet hours are from 10 pm to 8 am Sunday through Thursday and 12 AM to 8 am Friday & Saturday. "

The exact changes are:

**Changing quiet hours from 1am on non-school nights to hopefully 11PM if not 12AM**
